



## Girl Representative to the Board of Directors

Any High School age Girl Scout (grade 9 – 12) is eligible to serve as a Girl Representative to the Board of Directors. There are 3 Girl Representative positions on the Board, and the number available each year varies.

In this position, girls can serve up to 2 years, and will provide input on strategic issues facing our Council. Girls need to be able to actively participate and attend at least (3) Board meetings, including special events, where applicable, and the annual BOD Retreat. There are (4) Board Meetings per year, which are held at the Cherry Hill Service Center, on Wednesday evenings from 6:00pm to 9:00pm. The September all-day Saturday Board Retreat location is determined closer to September. At times, you will be asked to help out at programs or events.

Each June, Council identifies how many open positions are available for the coming year. Applications can be submitted at any time throughout the year. All applications submitted by July 31st, will be interviewed in August. Any applications submitted after July 31st, will be added to the queue for next year. Applicants that are interviewed in August and selected will begin their appointment at the September Board Retreat. If a girl is not selected, her application remains on file and she will be considered in future years during her high school career, unless the girl (or parent) withdraws her application.

### Requirements:

- Uphold and advocate for the mission, brand promise and vision
- Maintain annual Girl Scout membership
